

10. The Declaration allows for foreclosure of the Association's lien for failure to pay assessments.



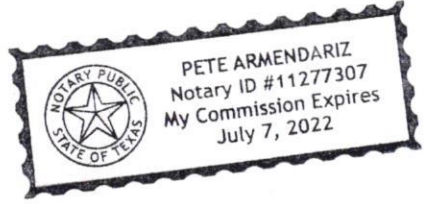
