Bylaw Article III E Proxies be amended by replacing it with:

The Association shall provide for votes to be cast in person, by absentee ballots or by proxy and may provide for voting by some other form of delivery. The proxy shall be dated and signed by the lot owner, allow for revocation and be valid for the meeting at which it is cast. Proxy and absentee ballots shall be returned to the property management company employed by the Casas Bellas Homeowners Association.

Votes cast by proxy are valid for the process of establishing a quorum. Ballots shall be counted by a neutral third party or by a committee of volunteers that shall be elected or appointed at an open meeting by the Chair of the Board. Volunteers shall not be Board members or candidates for election.

By Law Article VIII Officers and Their Duties G.6 Treasurer shall be amended by adding:

"shall work with the treasurer to prepare an annual budget: shall prepare monthly and annual statements of income and expenditure to be presented at Board and the Annual Meetings; shall keep proper books of the accounts."
