

**SUPPLEMENTAL DECLARATION AND MASTER DEED  
FOR  
VISTA DEL SOL UNIT ONE HUNDRED THIRTY-SIX  
STONEGATE SUBDIVISION**

This Supplemental Declaration, is made on the date hereinafter set forth by **EL PASO STONEGATE HOMEOWNER'S ASSOCIATION, INC.**, a Texas nonprofit corporation, hereinafter referred to as the "Association".

**WHEREAS**, Protective Covenants for Vista Del Sol Unit One Hundred Thirty-Six dated September 11, 1996, are recorded in Volume 3106, Page 322, Real Property Records of El Paso County, Texas (the "Protective Covenants"); and

**WHEREAS**, a Declaration and Master Deed for Stonegate Subdivision dated April 15, 1998, executed by Stonegate Joint Venture, is recorded in Volume 3350, Page 10, Real Property Records of El Paso County, Texas (the "Declaration"), which supplements the Protective Covenants by creating the Association, imposes assessments for the purpose of enhancing and protecting the value, attractiveness and desirability of the 54 lots within Vista del Sol Unit One Hundred Thirty-Six (the "Subdivision"), and provides for the care and maintenance of common areas that benefit all the lots within the Subdivision; and

**WHEREAS**, the Association desires to have Owners of lots within the Subdivision confirm that his, her or their lot is subject to the terms of the Declaration;




